

Summary of Firearm Violence Prevention Research in Houston

Firearm violence is a significant problem in Houston. The Harris County Medical Examiner's office reported approximately 500 deaths (adult and pediatric) by firearm per year until 2020, when the incidence rose even higher. Additionally, approximately 1,000 patients per year are treated for non-fatal firearm injuries at the level I trauma centers in the city. It is estimated that almost half of the homes in Texas have household firearms, and Texas is an open carry state. As a result, unintentional shootings to children (either due to negligent discharge or stray bullets) are also a significant problem and continuing to rise.

Our work has had two areas of focus: 1. Facilitating safe gun storage counseling by community

pediatricians and 2. Gaining detailed knowledge on the epidemiology of all firearm injuries in the city to identify individual, neighborhood-level ("hot spots") and community-level risk factors and social determinants. This work is fully funded by the CDC. Local and national data focus mostly on deaths by firearm and the burden of non-fatal injuries has not been well-characterized. Therefore, we aim to gain a comprehensive understanding of all firearm injuries based on shooting cause (homicide, suicide and unintentional) by combining injury data from the trauma centers, death records from the medical examiner's office, and crime data from police records. This data will then be useful to guide targeted city-wide injury prevention efforts in collaboration with city leadership.

ACS Jacobson Innovation Award

The Jacobson Award is the most prestigious research award given by the American College of Surgeons. We congratulate and celebrate Dr. Patricia Kilroy Donahoe as this year's honored recipient!

Known as the leading expert in reproductive development biology and oncology, Dr. Donahoe's career encompasses both pediatric surgery and innovation research. Begun in her surgical residency, her ongoing research on Mullerian Inhibiting Substance (MIS), changed the way we think of reproduction. MIS has clinical applications in the regulation of normal reproduction and a potential role in the control of ovarian and other reproductive tumors. Her research also contributed to the understanding of the molecular and genetic causes of birth defects, particularly congenital diaphragmatic hernia. One of the world's most influential reproductive scientists, she is unsurpassed in her contributions as a surgeon-scientist, mentor, and academic leader. For her lifelong and continued pioneering work, Dr. Donahoe is the honored recipient of the ACS 2021 Jacobson Innovation Award.



The APSA Outcomes and Evidence-based Practice Committee (OEBPC) utilizes the systematic review methodology to examine the current state of the literature and develop recommendations for pertinent, but unanswered, questions in the field of pediatric surgery.

2021 Annual Meeting Presentations

In conjunction with the Surgical Quality and Safety Committee, the OEBPC produced two systematic reviews for the 2021 APSA Annual Meeting.

- Review of inflammatory bowel disease where discussion focused around recommendations for optimal reconstructive procedures, diversion indications, timing of operation, use of biologics, and the pearls and pitfalls of the minimally invasive approach. The impact on fertility rates was also covered.
- Gastroschisis and the recommended timing of delivery, the choice and use of antibiotics, closure strategies, the role of monitoring to impact outcomes, a review of available feeding protocols, and strategies to improve outcomes for complicated gastroschisis.


Meeting registrants can watch both sessions via the meeting platform until mid-November, at which point all meeting material will be available on APSA's YouTube channel.

2022 Annual Meeting Presentations

Several topics are in the works, including a review of the state of the literature for spontaneous pneumothorax, management of venous thromboembolism, and biliary dyskinesia. Similar to 2021, this will be a collaboration with the Surgical Quality and Safety Committee and provide links to the toolkit so the recommendations can be easily implemented by members.


